GBCs



GBCs are tax resident entities governed by the Mauritius Companies Act 2001/Financial Services Act 2007

Authorised Companies



Authorised Companies are non-resident entities governed by the Mauritius Companies Act 2001/Financial Services Act 2007

Domestic Companies



Domestic Companies are tax resident entities governed by the Mauritius Companies Act 2001.

Trusts



Mauritius Trusts are governed by The Trusts Act 2001 (the "Act").

Foundations



Foundations in Mauritius are governed by the Mauritius Foundations Act 2012.

Partnerships



A Limited Partnership (LP) can be set up as either a domestic company or with a Global Business License.

PCCs



PCCs are governed under the Protected Cell Companies Act 1999.

Investment Advisor License



The Investment Advisor License is regulated by the Financial Services Commission ("FSC") in Mauritius.

Investment Dealer License



The Investment Dealer License is regulated by the Financial Services Commission ("FSC") in Mauritius.

Funds



Funds in Mauritius require approval from the Financial Services Commission before they commence business.

Global Headquarters



Multinational Companies are allowed to relocate their regional administration, procurement and accounting functions to Mauritius under the Global Headquarters Administration License.

Foreign Companies



A foreign company is registered in Mauritius as a Branch and allows the entity to continue the business activity of its parent (which is incorporated outside Mauritius).

International Business Companies (IBCs)



IBCs are offshore companies that are mostly exempt from all types of taxes in the jurisdictions of incorporation.

The VAITOS Act came into force on 7 February 2022 to enable the Financial Services Commission, Mauritius (FSC)...

VCC



A Variable Capital Company (VCC) is a company incorporated under the Companies Act which carries its...
